## **CLONEFEST TERMS AND CONDITIONS OF ENTRY**

- "Event" means the Event which you have bought a Ticket to attend being CloneFest.
- "Promoter" or "Us" for CloneFest means CloneFest Ltd and the companies' subsidiaries, holding companies, any subsidiaries of its holding companies and its agents, contractors, sub-contractors, representatives, servants and employees.
- "Terms and Conditions" means these terms and conditions.
- "Venue" means the Venue at which the Event takes place being licensed section of Sherdley Park St Helens
- "Ticket" means any valid ticket or wristband which permits you to attend the Event or any valid wristband for which you have exchanged your valid ticket at the Event.
- "You" means you as the holder of the Ticket and "Your" shall be read accordingly.
- CloneFest is subject to full license approval.
- Tickets are issued on behalf of CloneFest Ltd and are subject to the terms and conditions indicated below or displayed on the premises.
- Purchasers should note that tickets may be sold by an agent for the organisation responsible for the Event, and details of the organiser/promoter are available on request from authorised ticketing agents.

Purchase and possession of tickets means acceptance to agreement of the following conditions:

- 1. It is a strict condition of our licence that every ticket holder entering the Event must have a valid ticket AND Photo ID.
- 2. No under 18 years old are allowed into the Event or Venue. Challenge 25 is in operation.
- 3. CloneFest Ltd reserves the right to refuse You entry to the Event Venue.
- 4. It is the Your responsibility to carefully check your tickets in advance of the Event; mistakes may not be rectified on the day.
- 5. Tickets are issued subject to the rules and regulations of the Venue owners, operators and management.
- 6. There will be no refunds other than cancellation of the Event.
- 7. Strictly NO glass bottles to be brought in to the festival Venue. Any glass found may be confiscated.
- 8. No alcohol can be taken into the Event.
- 9. Any item that is deemed unsuitable may be refused at the discretion of CloneFest Ltd including...
  - devices capable, or appearing capable, of being used to cause serious injury by discharging a projectile.
  - b. objects with a sharp point or sharp edge objects with a sharp point or sharp edge capable of being used to cause serious injury.
  - c. workmen's tools tools capable of being used either to cause serious injury or to threaten a persons safety.
  - d. blunt instruments objects capable of being used to cause serious injury when used to hit,
  - e. explosives and incendiary substances and devices explosives and incendiary substances and devices capable, or appearing capable, of being used to cause serious injury or to pose a threat to the safety of a person.
  - f. glass containers, smoke canisters, chinese style lanterns, laser pens, gas BBQ's/portable cooking equipment, any illegal or offensive items, offensive weapons or potential weapons or other similar articles.
- 10. Any person in possession of such articles may be refused entry or ejected
- 11. Any person causing damage to the Venue, its infrastructure, or causes harm to any other person at the Venue may be excluded from the Venue and may be subject to prosecution.
- 12. Tickets and/or wristbands will not be replaced or duplicated in circumstances of loss or damage.
- 13. All Ticket holders agree to a voluntary search upon entry to the Venue. CloneFest Ltd reserves the right to refuse any persons and personal property and refuse admission to, or eject from, the Venue any person who refuses a voluntary search by a security official upon entry or inside the Venue.
- 14. CloneFest operates a no-readmission policy. No pass-outs will be issued from the Venue.
- 15. Ticket holders admission is st their own risk. The Licensee or CloneFest Ltd shall not be responsible for loss, injury or damage sustained at the Event including damage, theft or losses to property.
- 16. CloneFest Ltd can accept responsibility for lost or stolen property.
- 17. Camping is NOT permitted anywhere within the designated Venue or within Sherdley Park, St Helens.
- 18. Ticket holders give their consent to the use of their actual or simulated likeness in connection with the production, exhibition, advertising or exploitation of any film, video and/or audio recording of this Event and/or any element thereof in any/all media throughout the world. This includes filming by the police or security which may be carried out for the security of customers.
- 19. No professional photography, audio, audio visual or cinematographic recording equipment and/or devices shall be brought in to the Venue without prior written consent from CloneFest Ltd.
- 20. CloneFest Ltd reserves the right to change any performers, acts or details of the programme.
- 21. CloneFest takes place in an outdoor environment. Ticket holder and attendees are advised to wear appropriate clothing and footwear in the event of adverse weather conditions.
- 22. No animals are permitted into the Venue with the exception of special assistance dogs.
- 23. Strictly no trading allowed in the Venue without the consent of CloneFest Ltd.
- 24. Illegal substances may not be brought in to the Venue any substances found will be confiscated and may lead to prosecution.
- 25. WÄRNINGS:
  - a. Prolonged exposure to loud noise may cause damage to your hearing.
  - b. Strobe lighting may be used during the festival.
- 26. The sale and consumption of alcohol is strictly prohibited to persons under the age of 18 years. CloneFest LTD and its concessions employ the Challenge 25 policy. If you look under 25 years old you the onus is on You to prove that You are over 18 years old when you buy alcohol or tobacco.
- 27. The only acceptable forms of identification are either...

  - b. Valid passport
  - c. Driving licence.
- 28. Any person found to be behaving in an unsociable or potentially dangerous manner will be ejected from the Venue without refund.
- 29. Smoking is not permitted in enclosed public areas.
- 30. Medical treatments are dealt with by Remote Medical Services; which is a separate organisation to CloneFest LTD and CloneFest. CloneFest LTD and CloneFest are not therefore responsible for any problems arising from care provided by Remote Medical Services.
- 31. The possession of a ticket shall constitute an acceptance by the holder of these conditions and imply an undertaking on the part of the holder to observe them. In the Event of any breach of these conditions, CloneFest Ltd reserves the right to cancel the ticket and retain any monies paid therefore.
- 32. Other than the provisions advertised or outlined by CloneFest Ltd or the ticket agent at the time of sale, customers are required to address any special needs by contacting CloneFest Ltd or the ticket agent in advance of their visit, as CloneFest Ltd may not be able to provide those needs without notice.
